Teachers create material that will be given through many applications as well as to make it easier for students to understand the material being taught. Material is a source, a teaching or reading tool that is used as a support in learning (Ribeiro dkk., 2021). The material can be in the form of an interesting learning video by displaying animations related to the material taught by a teacher or teacher (Antony-Newman, 2019). One of the applications that is utilized is the Canva application (Sharif Matthews & López, 2019). Canva is an online application for displaying learning presentations, business and others. With this application, teachers make learning presentations using animated video illustrations regarding the material to be taught to be interesting (Ghani dkk., 2019). One of the learning media made with this canva application is the Arabic language learning media (Yoon dkk., 2020). This article discusses the problem of using the Canva Application as a Medium for Learning Arabic Class X, Al-mumtaz Islamic High School, Solok City (Karlsson dkk., 2020). This Arabic language certainly has a certain history in its meaning.

Arabic is grouped in one class with Mandarin, Cantonese, Japanese and Korean. This matter strengthens the discovery of Thomas Irving which explains some of the difficulties in learning Arabic. Among the difficulties are many of the different sound systems in the delivery of other languages, including Indo-European languages. The next difficulty lies in the complexity of the affixation system (isytiqâq). Then, with the many changes in the form of the term and the number of vocabulary or mufrodat that need to be mastered in the learning process. The word affixation comes from English, which means Affixation, this word is a family of words from Affix, which means addition or bubuhan. Affixation is a process of affixing to a unit, both the unit is like a single form or a complex form, for the formation of a word. Inaccordance with the above opinion, Chaermentioned that affixation is the stage of affixing toone of the fundamental words or forms. In the process of affixation tekait with elements, such as:

- 1. Introduction or basic form,
- 2. Afiks
- 3. Grammatical sense inform

The basic form is a morphemetic form that has not yet obtained an affix (affix); it can be a free morpheme, a base morpheme, and a unique morpheme. Affixes are bound morphemes that can be grouped according to the place of standing in the basic or original form, namely prefixes, prefixes, suffixes, simulfixes, affix combinations, and prefixes (Luqman, 2019).

Based on the opinion of Abdul Wahid Wa'fiy explained that the information that had previously been *recorded* from the times to humans today. *Arabic history* discourse is the result of discoveries derived from relics in the form of inscriptions about the *Baidah Arabian* which for example developed in the first century BC, after the fifth century AD the arabic baqiyah began to develop, until the stages of growth of Arabic language are very difficult to trace.

Anwar G. Chejne gives a matter that is no less the same, namely that the information about arabic language using the results of the stroke of the pen is still very small When compared to using other languages, as a result of which the periodization of arabic and its literature is only limited to the age of ignorance, the age of the entry of Islam, which was brought by the Prophet Muhammad Saw, the Umayyad period and the time of the Abbasids, the period of decline and the latest period. Related to the periodization above, which was resisted by experts about the growth of the Arabic language, namely since pre-Islam (Jahiliyah) where at that time there had been works of Arabic literature both verses and speeches that did not highlight certain dialects, using Arabic was easy to understand. using this path, then a literary Arabic language was formed, which as the standard (standard) language used by each poet in conveying his ideas (Profile, 2019).

In learning arabic, one must understand nahwu and sharaf first, then master the four skills or maharah in Arabic, the four maharahs are, maharah istima' or hear, maharah kalam or pronounce, maharah qiroah or read, and maharah kitabah or writing (Taubah, 2019). The four maharahs are inseparable, because the key to learning Arabic is these four skills. Apart from these four skills, mastery of vocabulary is certainly also one of the things that must be mastered in learning Arabic. After someone applies the four maharahs, they will easily understand the Arabic language.

However, learning Arabic in school environments such as junior high schools and high schools has received less attention than other subjects. This can lead to the diminishing ability of students in Arabic. In addition, the lack of motivation and learning media used when learning makes it difficult for students to understand the meaning of the Arabic language (Saleh, 2020).

Learning media is a tool or tool that plays an important role and is needed in the learning process in the classroom and outside the classroom. This medium aims to support learning to be more effective, making students more interested in learning and practicing after studying the material (Ihlebæk, 2018). In the process of learning media has a function, namely (Nicolaou, 2019):

- 1. Used as a tool to help achieve an efficient and interesting learning atmosphere
- 2. One of the compounds that has a relationship between one and the other
- 3. Accelerate learning process
- 4. Improving quality in the PBM system
- 5. Abridged transcendental thing in order to narrow the problem of verbalism supporting tools in learning things that are very useful for an educator in assisting in the teaching process.

Moreover, becoming an educator in this day and age, everything that is used uses technology. Educators must be able to take advantage of this technology to make facilities in teaching and learning that are so attractive so that students do not feel boring (Jeong, 2018). In addition to the factors of technological development that make educators must be able to be creative in making learning media, there are other factors that make educators have to take advantage of the technology, the test factor is a factor in the current world conditions.

The current conditions require everyone to do anything only at home without touching or crowding with the general public, which causes all of this to happen is the impact of the covid 19 pandemic. Coronavirus means a large clump of viruses that cause disease in humans and animals. In humans it will generally cause respiratory infections, ranging from the common cold to serious diseases such as Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS) (Salloum, 2021). The COVID-19 pandemic is a situation that requires someone to keep a distance from others, especially people affected by the covid 19 virus. This also has an impact on the teaching and learning process in schools. The teaching and learning process is moved to their respective homes by conducting virtual learning. If there are advantages that can be obtained an application then of course there are also disadvantages of the application, this Canva application has a fundamental weakness that can be obtained in this application, namely if you want to use Canva, every user must have a data package so that it can be connected and can using Canva, in addition to the designsdisplayed in the Canva application there are a number of templates that are paid, but this is not a problem, because many templates are good but free when used(Garris Pelangi, 2020). Below is how to use the Canva application for free without having to download it first on android and pc.

- 1. Open google chrome on the android or pc used
- 2. Next type CANVA on android or pc

- 3. Click on the pre-selected web then it will display the beginning section as in the image
- 4. This is the display of menus on the Canva application

- 6. Next is an element that serves to add elements in the form of lines, graphics, plants and many elements that can be displayed

- 10. Audio to add audio or music to a presentation slide
- 11. Video serves to add videos according to the animated video you want to display
- 12. In the animate section shown the arrow is the part to set how the animation is positioned when entering

In an Arabic language study there are four maharahs in it, one of which is maharah kalam or pronunciation. When students are able to master maharah istima' or hear it then they proceed to maharah kalam for pronunciation, the educator gives an animated video and then asks the students to practice it again (Sa`diyah, 2018). In this application, educators can display an animated image or video to students in the form of a video of a conversation between two or more people.

Apart from maharah kalam, educators can also explain how to write Arabic letters on this canva application (Husain, 2021).
